ORDER.

falls within the domain and territorial jurisdiction of Gilgit-Baltistan

Service Tribunal (GBST) at Gilgit. He prays that the Impugned

Judgment dated 02.05.2016 in Appeal No. 481 (R) CS/2014 passed

by the learned Federal Service Tribunal, Islamabad is not

sustainable and the same is required to be set aside.

3. Be it may, the petitioner/the Provincial Government of

Gilgit-Baltistan can not approach this court directly. They may seek

remedy in a proper forum/ Court of law provided under the law. In

case no alternate remedy is available to the petitioners they may

approach to the proper forum i.e. the learned Gilgit-Baltistan Chief

Court in its writ jurisdiction.

4. In view of the above discussions, this petition is disposed

off in above terms, however, the petitioners may approach to the

proper forum/Court of Law, if they so advised.
