JUDGMENT.

Dr. Rana Muhammad Shamim, CJ..... A News was published in Daily Waddi Newspaper dated 03.04.2017, regarding "Undue and Out of Turn Promotion" in Police Department Gilgit-Baltistan. On such News clippings the learned Registrar of this Court reported the matter to the Hon'ble Chief Judge for taking Suo Moto Notice under Article 61 Read with Article 95 of the Gilgit-Baltistan (Empowerment and Self Governance) Order, 2009. Before taking Suo Moto Notice, office of this Court was directed to seek report from the Inspector General of Police Gilgit-Baltistan. Consequently, the Inspector General Office vide letter No. IGP-4(5)-E-1/3697/2015 dated 12.04.2017 informed to the office of this Court that the Police Department Gilgit-Baltistan has already taken necessary steps against the "Undue and Out of Turn Promotion" made without constituting Department Selection Committee (DPC) etc. In this regard, the office of this Court, has sought data of all "Undue & Out of Turn Promotion" of all districts and union

branches of Police Department Gilgit-Baltistan. The office of the

Inspector General of Police Gilgit-Baltistan through letter No. IGP-

1(2)/EX-1/12007/ 2017 dated 23.10.2017 filed a comprehensive

report mentioning therein three categories of promotions i.e. (1).

Shoulder Promotions (2). Undue/Out of Turn Promotion (3).

Promotion granted without fulfilling of mandatory trainings as per

existing Police Service Rules. The detail of the said report is as

under:-

a. The details of the officers/officials in Districts, units & Branch of

Gilgit-Baltistan police who have been given shoulder promotion is

attached herewith (From Annex-A to S) showing their actual rank

and shoulder rank.

b. The details of officers/officials of Gilgit-Baltistan police who have

been promoted out of turn, is attached as Annex-T.

c. The details of officers/officials of Gilgit-Baltistan police who have

been promoted without following codal formalities, existing rules

and without qualifying mandatory police courses is attached Annex-

U.

2. The Secretary Home and Prisons Department Gilgit-

Baltistan has also submitted a letter No. IGP-1(41)/15055/2017

dated 20.12.2017 written by the Assistant Inspector General Police

Gilgit-Baltistan regarding "Shoulder & out of Turn Promotion"

Please refer to Home & Prisons Department GB letter NO. SO (P)-1(28)/2017(inquiry), dated 22nd December, 2017, alongwith the attested copy of the Order of the Hon'ble Supreme Appellate Court GB, dated 22.11.2017, in Suo Moto Case No.10/2017.

In compliance with the orders of Hon'ble Supreme Appellate Court in the subject Suo Moto Case & in pursuance of the decision taken in the meeting at Home Department GB, on December 19, 2017 the report has been complied after scrutiny of the available record regarding Police officers/officials of Gilgit-Baltistan Police Department promoted out of turn, without qualifying mandatory police courses, without completing codal formalities, without lawful authority and those who have been granted shoulder promotion, as under;

OUT OF TURN PROMOTIONS:-

1.The details of officers/officers earned out of turn promotions in Gilgit-Baltistan Police is enclosed herewith as Annexure-A. Presently, neither any law nor any rule exist, which authorize any authority to grant out of turn promotions on the acts of gallantry or extra ordinary performances, how commendable and appreciated by the society.

PROMOTIONS WITHOUT MANDATORY POLICE COURSES:-

2. The professional police courses and enlistment of officers to various promotion lists are mandatory for promotion from one rank to another rank, have been prescribed in Police Rules, 1934 and in the Recruitment & Promotion Rules of Gilgit-Baltistan Police, notified vide S.R.O 68(1)/2004 dated 9th January, 2004, to determine the eligibility of an officer for promotion to next rank. The types of mandatory police course required for promotion to various ranks are as under, however the details of promotion lists have been discussed at para-6.

A. Lower School Course:-

The Rule 13,8 List-C. Promotion to Head Constable; (Police Rules, 1934) stipulates that:

"In each District a list shall be maintained in card index Form 13.8 (1) of all constables who have passed Lower School Course at Pillar and are considered eligible for promotion to head constable".

The Lower School Course is mandatory course for a Constable in the seniority List-B, for his admission to List-C. The List-C, which is maintained in the District for Constables, who have qualified Lower School Course and are eligible for promotion to the rank of Head Constables (Rule 13.8).

B. Intermediate School Course:-

Rule 13.9 List-D. Promotion to Assistant Sub-Inspector; (Police Rules, 1934) stipulates that:

"A list shall be maintained in each District in card index Form 13.9(1) of those head Constables who have passed the lower school course and the intermediate school course at the Police Training School and are approved by the Deputy Inspector-General as eligible for officiating or substantive promotion to the rank of Assistant Sub-Inspector. No head Constable shall be admitted to this list who is not thoroughly efficient in all branches of the duties of a constable and head constable and of established integrity".

C. <u>Upper School Course</u>

The upper school course is a pre-requisite police course for promotion from Sub-Inspector (BS-14) to Inspector (BS-16), laid down in Part-II, Conditions for Promotion; in the approved recruitment & promotion rules of Gilgit-Baltistan Police, notified vide S. R. O 68(1)/2004 dated 9th January, 2004, as follows;

- a. 05 years of service in the field of Investigation (BS-14).
- b. One year training from Police Training Institute/Academy.

The Standing Order No.9 of 2007 issued by Inspector General of Police Gilgit-Baltistan after the approval of Government vide Dy.No.954/2005/NA-II, also stipulates the following eligibility criteria for promotion to the rank of Inspector (16);

- a. Officer not qualifying Intermediate and Upper School Course shall not be eligible for promotion to the rank of Inspector (BS-16).
- b. No officer shall be confirmed in the rank of SIP, unless he has passed upper school course.

D. Advance Class Course

The Advance Class Course is a pre-requisite police course for promotion from Inspector (BS-16) to Deputy Superintendent of Police (BS-17), laid down in Part-II, Conditions for Promotion; in the approved recruitment & promotion rules of Gilgit-Baltistan Police, notified vide S. R. O 68(1)/2004 dated 9th January, 2004, as follows;

- c. 03 years of service in as Inspector (BS-16).
- d. One year training from Police Training Institute/Academy.

The Advance Class Course is mandatory for promotion from Inspector (BS-16) to the rank of DSP (BS-17) in Punjab Police and other police organizations.

It is pertinent to mention that no any authority is competent to exempt any officer from the afore-mentioned mandatory police courses enshrined in Police

Rules, 1934 and in Recruitment/Promotion Rules of Gilgit-Baltistan Police, except the authority which has framed these rules.

3. The details of officers/officials promoted without mandatory courses are enclosed herewith as Annexure-B. All such officers who have not undergone the pre-requisite police courses mentioned against each and promoted to higher ranks, may be given time frame of 20 months to complete all the courses mandatory of each rank. The officers at S. No. 2 to 22 have already been promoted to the rank of DSPs in their turn, but they were not nominated to undergo Advance Class Course prior to their promotion. However, these officers have now been nominated to undergo Advance Class Course at Police Training College Gilgit.

EX-CADRE PROMOTIONS:-

- 4. The Police Act, 1861 & Police Rules 1934, envisages the Police Force one indivisible body possessing various establishments performing assigned functions such as District Police, Reserve Police, Crime Branch, Special Branch, Police Training College and so on. Each of these establishments are in fact integral parts of the police force, and under no rules of construction they can be construed as a separate or independent cadre. The appointments and enrollments of the Police personnel are regulated by Rule 12 of the Police Rules, 1934 of Chapter XII, which deals with three different sets of recruitment processes described thereunder:
 - a. Recruitment in prosecution (Legal Branch), Rule 12.6(3)(C).
 - b. Recruitment of Technical District, Rule 12.3(B)
 - c. Recruitment of upper subordinates in Police, Rule 12.6.

There is a difference in the training courses of the personnel appointed in the aforementioned units as prescribed in the Police Rules.

- a. Training of personnel:-
- i. Constable, Rule 19.2
- ii. Upper subordinates, Rule 19.25
- b. Training of officers in prosecution (Legal Branch), Rule 19.26.
- c. Training of officers in Technical District, Rule 12.3(B)(2).

"After recruitment no Inspector (Legal) shall be allowed to change of cadre from Inspector (Legal) to the Executive of any other Branch in the Police Department".

The Supreme Court of Pakistan in its judgment dated 04-11-2015, on Civil Petitions No. 493, 494, 505 to 508, 529 to 532, 533, 601, 906 and 911 to 917 of 2015 has held that,

"On the basis of the aforementioned criteria of recruitment and training in terms of the Rules referred to hereinabove, it can be easily concluded Police force has Three independent units i.e. Executive, Technical and Prosecution (Legal),. On scanning the rules it can be further concluded that Police personnel appointed in terms of the aforesaid recruitment process cannot horizontally travel to any other unit referred to hereinabove either by way of transfer or otherwise. We may, however, observe that Rule 12.8 of Police Rules 1934 provides recruitment

process and training program from Constable to Inspector in the Police Establishment (Executive Unit) is common".

Therefore, Police personnel once appointed in any of the abovementioned three independent units i.e. Executive, Technical and Prosecution (Legal) cannot legally be transferred, merged or otherwise to any other unit.

5. The leave to appeal titled "DSP Abdul Rauf etc. Vs Provincial Government" against the judgment of Hon'ble Chief Court Gilgit-Baltistan regarding merging of seniority of DSPs Legal with DSPs of executive Branch of Gilgit-Baltistan Police is sub-judice in the Hon'ble Supreme Appellate Court. In pursuance of above quoted police rule and the judgment of Supreme Court of Pakistan, the officer appointed in Prosecution (Legal) & Technical Branch, cannot be merged or transferred to Executive Police; hence, to give equal opportunity in career progression to the officers in each unit, directions if given for creation of senior cadre posts in their respective units shall be complied with immediately. However, no other cases of ex-cadre promotions have been found in Gilgit-Baltistan Police.

PROMOTIONS WITHOUT COMPLETING CODAL FORMALITIES:-

- 6. In pursuance of the spirit of Police Rules, 1934 and the judgment No. C.P.529-2015, of Supreme Court of Pakistan, there are six (06) common seniority/promotion lists maintained in the Police Department as per seniority and qualification (Trainings and promotional Courses) of the personnel in various ranks. The enlistment to these promotion lists is mandatory prior to their promotion to next rank i.e.:-
- i. <u>Promotion List-A:</u> List-A, maintained in the District for Constables having 3 years' successful completion of probationary period & found fit for promotion to the list-B. (Rule 13.6).
- ii. <u>Promotion List-B:</u> List-B, maintained in the District for Constables, who are present in List-A and found eligible to be sent to Lower School Course, which is promotional training for promotion to the rank of Head Constable, (Rule 13.7).
- iii. <u>Promotion List-C</u>:- List-C, maintained in the District for Constables, who have qualified Lower School Course and are eligible for promotion to the rank of Head Constable, (rule 13.8).
- iv. <u>Promotion List-D</u>:- List-D, prepared in the District and forwarded to the Range DIGP for approval and maintenance of seniority list. This list includes Head Constables eligible for promotion to the rank of ASI after successful completion of Intermediate School Course. (Rule 13.9)
- v. <u>Promotion List-E</u>:- List-E, maintained by the Range DIGs, containing confirmed ASIs, who are eligible for promotion to the rank of Sub-Inspectors. Rule 13.10).
- vi. <u>Promotion List-F</u>:- List-F, prepared by CPO on the recommendations of Range DIGs and maintained by Central Police Office (CPO) on the centralized basis, containing confirmed Sub-Inspectors, who have qualified Upper School Course and eligible for promotion to the rank of Inspectors. (Rule 13.5).

The details of officers/officials promoted without completing codal formalities enclosed herewith as Annexure-C. These officers have been promoted without being admitted to above mentioned promotion lists and without DPC proceedings.

LAWFUL AUTHORITY FOR PROMOTION FROM ON RANK TO ANOTHER:-

7. The details of officers promoted without lawful authority have been enclosed herewith as Annexure-D. It is pertinent to elucidate here that under the Police Rules, 1934, the seniority of the Constable and Head Constable is maintained in the District, whereas seniority of ASI and SIP is maintained by Range DIG. The seniority of Inspector in Police is maintained by Central Police Office. The Supreme Court of Pakistan pursuance of above rules, in its judgment No. C.P.529-2015 has held that;

"All the establishments, other than the executive police establishment, i.e. District Superintendent of Police and Range DIG, are barred from making direct or indirect recruitment or promotion. Being the custodian of the service record etc. of the Police personnel, the District Superintendent of Police/Range DIG, shall make selection for police training and practical training, and no other establishment shall be authorized to make such selection. By way of clarification it may be observed that the matters related to seniority, promotion or trainings in respect of Police inspector, the competent authority is Inspector General of Police, as provided in the Police Rules 1934".

8. In pursuance of the above referred judgment of Supreme Court of Pakistan and the spirit of Police Rules 1934, and the departmental promotion committees notified by the Government, the following are the authorities competent for appointment/promotion in Police Department Gilgit-Baltistan:

9. The details of Police officers/officials who have been given shoulder promotion is enclosed herewith as Annexure-E. It is also pertinent to apprise, that SP (BS-18), transferred and posted to officiate the office of Range DIG, have been allowed to wear the rank of SSP (BS-19), on his own pay and scale. Similarly, DSsP (BS-17), transferred and posted to officiate the office of District Superintendent of Police, due to shortage of officers at the rank of SP(BS-18); have been allowed to wear the rank of SP, on their own pay and scale, while keeping their seniority of the rank in consideration. Likewise, the Inspectors (BS-16), transferred and posted to officiate the office of Sub-Divisional Police Officer, due to shortage of officers at the rank of DSP (BS-17), have been allowed to wear the rank of DSP, on their own pay and scale, while keeping the seniority of the rank in consideration. However, on their transfer from the post of DIG, District Superintendent of Police & SDPO, they have to put on their actual ranks.

Besides, the Inspectors Police when posted to officiate the office of Sub-Divisional Police Officer (SDPO) are also allowed to wear the rank of DSP. However, on their transfer from the post of Superintendent of Police & SDPO, they have to put on the rank of DSP & IP respectively.

4. A substantial material was received by this Court regarding the "Undue & Out of Turn Promotion" in Gilgit-Baltistan Police Department. Consequently, the case was taken up in Court on 22.11.2017 under Article 61 read with Article 95 of the Gilgit-Baltistan (Empowerment and Self Governance) Order, 2009 (herein called as Order, 2009) read with Article 184(3) of the Constitution of the Islamic Republic of Pakistan 1973. Both the aforementioned articles 61 & 95 of the Order, 2009 and Article 184(3) of the constitution of the Islamic Republic of Pakistan are reproduced for convenience as under:-

"Quote"

ARTICLES (61) &(95) OF THE GILGIT-BALTISTAN (EMPOWERMENT AND SELF-GOVERNANCE) ORDER, 2009:-

Article 61. original jurisdiction: (1) without prejudice to the provisions of Article-71, the supreme Appellate court, on an application of any aggrieved party, shall if it considers that a question of general public importance with reference to the enforcement of any of the fundamental rights conferred by part II of this Order is involved, have the power to make declaratory order of the nature mentioned in the said Article.

(2) An application made under clause (1) shall be heard by a Bench comprising not less than two judges to be constituted by the Chief Judge.

Article 95 order to override other laws, etc:-

The provision of this order shall have effect notwithstanding anything contained in the provisions of any law for the time being in force except that in case if conflict between the laws of Pakistan and the laws framed under this order, the laws of Pakistan shall prevail.

2. <u>ARTICLE 184 (3) OF THE CONSTITUTION OF THE ISLAMIC REPUBLIC OF PAKISTAN 1973:-</u>

ORIGINAL JURISDICTION OF SUPREME COURT:-

(3) without prejudice to the provisions of Article 199,the supreme court shall, if it considers that question of public importance with reference to the enforcement of any of the Fundamental Rights conferred by Chapter I of Part II is involved, have the power to make an order of the nature mentioned in the said Article.

"Unquote"

- 5. The power and authority to take Suo Moto notice is available to this Court under Article 61 read with Article 95 of the Gilgit-Baltistan (Empowerment & self Governance) Order, 2009 is akin to the power conferred upon the Hon'ble Supreme Court of Pakistan under Article 184(3) of the Constitution of Pakistan 1973. That in case of conflict between the laws of Pakistan and the laws framed under the Order, 2009, the law of Pakistan shall prevail.
- 6. In view of the above provision of law, Article 184 (3) of the Constitution of Pakistan shall prevail while taking Suo Moto action/notice by this Court. This Court has taken cognizance of the matter accordingly as question of public importance with reference to the enforcement of any of the fundamental rights conferred by Part-II of the Order, 2009 is involved. The decisions rendered by the Supreme Appellate Court under its original and appellate jurisdiction are enforceable throughout Gilgit-Baltistan whereas all the executive and judicial authorities in Gilgit-Baltistan have to act in aid of the Supreme Appellate Court in implementation of its

judgments as provided in the sub articles (2) and (3) of the Gilgit-Baltistan (Empowerment & Self Governance) Order, 2009.

- **7**. It is further clarified that under Article 184 (3) of The Constitution of The Islamic Republic of Pakistan regarding its Original Jurisdiction in case the Supreme Court of Pakistan, if it considers that question of public importance with reference to the enforcement of any of the Fundamental Rights conferred by Chapter I of Part II is involved, have the power to make an order of the nature mentioned in the said Article. Likewise this court in such situation if anything or material comes in its notice, this court in pursuance of Article 95 of the Order, 2009 is empowered to take cognizance as provided under Article 184(3) of the Constitution of Pakistan. Since, the "Out Of Turn Promotions" in Gilgit-Baltistan is/was unprecedented which relates to the question of general public importance and infringement of fundamental rights to large number of poor police officials, therefore, this court took Suo Moto and heard the case at length.
- 8. It is pertinent to note with pain that the aforementioned police officers/officials of police department Gilgit-Baltistan who have been granted "undue and Out of Turn Promotions" etc without observing the codal formalities and mandatory Police Rules which in our considered view are not tenable in law. For convenience the detail of such Police Officers/Officials of Gilgit-Baltistan Police is reproduced hereunder:-

9. While hearing this case, we have been fortified by the judgments delivered in an identical nature of cases by the Hon'ble Apex Court of Pakistan i.e. in case titled Shahid Pervaiz versus Ejaz

Ahmed & others reported as 2017 SCMR 206, whereby the larger bench of the Hon'ble Apex Court of Pakistan has held that "Out Of Turn Promotions" were inherently destructive to the rights of other officers who, though senior and entitled to be considered for promotion before the beneficiaries of "Out of Turn Promotions", were bypassed as a result such out of turn promotions. Each out of turn promotion necessarily had a corresponding effected officer, who suffered due to such exercise despite being completely blameless. He suffered for such no fault of his own when he was bypassed in favour of beneficiary of such an exercise unless he voluntarily waved his rights, in which case the promotion could no longer be described as out of turn. The Courts ought not to ignore his right in matters brought before it for adjudication, irrespective of his presence or absence before the Court in a particular case. Out of turn promotion was not only against the constitution but also against the injunctions of Islam. Reward or award should be encouraged for meritorious public service but should not be made basis for out of turn promotion. In others identical cases i.e. Muhammad Nadeem Arif Versus I.G. of Police reported as 2011 SCMR 408, in case of Ghulam Shabbir versus Muhammad Munir Abbasi reported as PLD 2011 SC 516 & in a case of contempt proceedings against Chief Secretary Sindh reported as 2013 SCMR 1752, whereby it was held that brunt of out of turn promotions were always borne by the individuals officers who were bypassed. The damaging effect on the carriers of the deserving officers who

suffered due to out of turn promotion constitute during service and even after retirement in terms of pensionary benefits. If the beneficiaries of such illegal exercise were reverted to the positions to which they would have be entitled to, on their respective merits and promotions, it would immediately open up vistas of promotions for those deserving officer who were earlier bypassed due to out of turn promotions. Acts of gallantry, no matter how commendable and appreciated by the society did not justify out of turn promotions as they necessarily lead to impingement of the fundamental rights of the fellow officers in terms of blocking their smooth progression of carriers and impinging their respect and honor is protected under Article 9 and 14 of the Constitution. Supreme Court directed the concerned officials and authorities to fix the seniority of all the police officers who were given out of turn promotions alongwith their batch mates as if they were never given out of turn promotions.

10. The Hon'ble apex Court of Pakistan was also pleased to hold in case titled "Aman Ullah versus Government of Baluchistan & 02 others reported as 2017 SCMR 192 that act of extending favour and conferring benefits of promotions was not only against the fundamental rights of promotions of appellant's peers on merits but, was also of glaring example of nepotism and undue favour, which act was also opposed to oath of office of the provincial Chief Minister. Out of turn promotions of appellants on the directions of the Provincial Chief Minister could not be sustained.

- 11. The Hon'ble apex Court of Pakistan while hearing and deciding various petitions and Review Petitions reported as 2017 SCMR 868 was also pleased to hold that the concept of "out of turn Promotions" was unconstitutional. Police was a disciplined force and officials/officers employed in the police should not have embarked upon unnecessary litigations of claiming "out of turn promotions";, if, however, any police official had a genuine grievance he should have taken the same before the forums that the law provided instead of initiating proceedings before the High Court under Article 199 of the Constitution. Provincial Inspector General of police had considered the judgment of the Hon'ble Supreme Court with regard to the "Out of turn promotions cases" and issued notices to all concerned official and gave them opportunity of hearing whereafter he passed separate detailed order in respect of each police official. The Hon'ble Supreme Court directed that the report of the provincial Inspector General should be acted upon and notifications with regard to withdrawing the "out of turn promotions" be immediately issued.
- 12. The Hon'ble Apex Court of Pakistan was also pleased to hold in case titled "Regional Police Officer Gujranwala & another versus Ejaz Ahmed & others" reported as 2016 SCMR 1525 that no civil servant (or police personnel) was entitled to out of turn promotion on account of gallantry awards or otherwise. It has further declared that ante dated seniority to a civil servant is violation of the law. Out of turn promotion ranging from constable

to any gazette officer shall be streamlined in terms of judgments reported as 2013 SCMR 1752 2015 SCMR 456.

- In case titled "Ch. Muhammad Akram versus Registrar Islamabad High Court & others" reported as PLD 2016 SC 961, the Hon'ble Supreme Court of Pakistan has held that once, the court has satisfied itself that the matter in hand was one that affected the public at large and involved the infringement of fundamental rights protected under the constitution, there remained no bar on its competence to entertain a petition under Article 184 (3) of the Constitution. In matter of "public importance" if it is directly and vitally concerned the general interest of the community or public at large as opposed to the particular interest of an individual.
- 14. The Hon'ble Supreme Court of Pakistan was also pleased to hold in another identical case titled Farhat Abbass versus IG & others reported as 2009 SCMR 245 that performance of duty with due diligence and efficiently deserved due appreciation but it could not be over appreciated out of proportion so as to make out a case of grievance to other employees in service of department. If a case of glaring favoritism was made out resulting in malafide action, the same had to be rectified in accordance with law to avoid injustice. Practice of such Out of Turn Promotion would encourage a person to obtain any other using underhand means or otherwise and then to claim immunity for such acts which would, therefore, result in rewarding the person using such means by allowing him to

continue to enjoy fruits of such ill-gotten gains which would perpetuate injustice.

- The Hon'ble Supreme Court of Pakistan was also pleased to hold in case titled Ali Azhar Khan Baloch versus Province of Sindh & others reported as 2015 SCMR 456 that Civil Servant exhibiting act of gallantry while performing his duties. The word gallantry as used in S. 9-A of the Sindh Civil Servant Act 1973, could only apply to police personnel and award & reward on their gallantry performance should be conferred upon them and not to other species of Civil Servant. Such award or reward, however, should be given under a transparent process after objectives assessment of their valour by a committee, in a just manner under the prescribed rules.
- We have heard the learned Advocate General appearing on behalf of the Government of Gilgit-Baltistan alongwith the learned Secretary Home and the learned DIG on behalf of the Inspector General of Police Gilgit-Baltistan, perused the material on record, gone through the report(s) submitted by the Police Department Gilgit-Baltistan and the Home Department Gilgit-Baltistan respectively. We have also perused the "Annexure-U" which shows the police officers/officials of Police who have been promoted without fulfilling the codal formalities of the Mandatory Requisite Training and Courses. The same is reproduced hereunder:-

17. It is shocking to note that how and in what manners they were promoted Out of Turn by violating the Mandatory Requisite Trainings and Courses. It is settled principle that violation of any mandatory provisions are not condonable under any law which vitiates the whole process of such illegal and unconstitutional Out of Turn Promotions. Such promotions are inherently destructive to the rights of the officers who though senior and entitled to be considered for promotions before the above beneficiaries of Out of Turn Promotions were bypassed and there were deprived from well deserved promotion on merits. The aforementioned case laws and parameters laid down by the Hon'ble apex Court of Pakistan are fully applicable and enforceable in this case as well. We have also gone through the provisions of Article 61 & 95 of Gilgit-Baltistan (Empowerment & Self Governance) Order, 2009 and Article 184(3) of the Constitution of Islamic Republic of Pakistan 1973. The perusal of the aforementioned Statues, case laws, and the Police Service Rules, transpires that admittedly the Officers/Officials of the Police Department Gilgit-Baltistan have been granted Undue/ Turn Promotions. Promotions without fulfilling the Codal/Formalities i.e. without obtaining the pre-requisite trainings and/or promotions without lawful authority. Due to granting of the

aforesaid Promotions, the batch-mates/colleagues the beneficiaries have been deprived from their due promotions/ seniority rights and they have been discriminated which could not be encouraged by this Court. The Gilgit-Baltistan Police is a disciplined force which has the pivotal role in maintaining the "law and Order situation" in the entire region. They should always have been appreciated by providing them each and every due rights in terms of their promotions etc, so as, their moral may always be boost up/beefed up. In our considered view, the notion of "out of Turn Promotion" is unconstitutional, illegal, unlawful, illegitimate and against the fundamental rights conferred under Chapter-I of Part- II in the Constitution of The Islamic Republic of Pakistan, 1973 as well as enshrined in the Articles 03 to 19 Part-II of the Gilgit-Baltistan (Empowerment and Self-Governance) Order, 2009, therefore, such Out of Turn Promotions are not tenable in the eyes of law. The Promotion to the Civil Servants could only be granted on the basis of their seniority-cum-fitness after completing certain legal codal formalities by the competent authorities as prescribed by the Civil Servants Rules as well as Police Rules. Out of turn promotions causes injustice to other colleagues/batch-mates which certainly creates frustration, disappointment and disturbance to those who are/were deprived & suppressed in circumstances. The Officers/Officials of Gilgit-Baltistan police who performs bravery, gallantry and diligent services must be awarded/rewarded with due appreciation but they cannot be granted/given "Out of turn

Promotions" and/or promotions without completing the Requisite Mandatory Courses and without fulfilling the codal formalities of the prescribed Services/Police Rules by creating an environment of frustration, annoyance and sense of depravity amongst all officers/officials of Police on the basis of glaring favoritism, nepotism, partiality, political motives and malafidy, which is, of course, is considered to be illegal, unconstitutional, ab-initio void and without lawful authority.

18. Both the Constitution of Pakistan & the Gilgit-Baltistan (Empowerment & Self-Governance) Order, 2009, provides security of person to their life and liberty. The term "life and liberty" is significant as it covers all the facets of human existence. The inhabitation against its deprivation extends to all those limbs and faculties by which life is enjoyed. The term "life" includes 'reputation' 'status' and all other ancillary privileges which the law confers upon the citizen. The Civil Servants are fully protected under Article 9 of the Constitution as well as under Article 3 (Part-II of the Fundamental Rights of the Order, 2009, who cannot be deprived from their right of reputation, status and opportunity of the promotions in next grades/scales by discriminating them and depriving them from their due rights. The granting of "Out of Turn Promotion, unlawful and undue promotions to the beneficiaries would not only be unconstitutional without undertaking competitive and transparent process but would also deprive the seniority and progression of the career of other meritorious Police personnel. The

out of turn promotions given by the then authorities of Gilgit-Baltistan police does not creates a perpetual right to the beneficiaries gained on the basis of illegal order(s) which can be set aside at any time.

- 19. The case in hand is a case of general pubic importance with reference to the enforcement of any of the fundamental rights as prescribed in Part-II of the Order, 2009 is involved which has far reaching effects on the service rights of Police officers/officials of the Police of Gilgit-Baltistan; therefore, this court was constrained to take Suo Moto notice in order to redress their grievances.
- 20. In view of the above discussions and parameters laid down by the Hon'ble apex Court of Pakistan, we, vide our short Order, dated 05.04.2018, have set aside all the "Out Of Turn Promotions" made till date by directing the Police Authorities to revert all such illegal beneficiaries back to their original ranks/positions/posts. The learned Home Secretary and the Inspector General of Police Gilgit-Baltistan were directed to submit compliance report within two (02) weeks positively.
- 21. As submitted by the learned DIG Gilgit, certain necessary Shoulder promotions given to certain police officials purely on temporary basis in their own pay and scale were requested to be maintained, if so required, with the permission of learned Inspector General of Police Gilgit-Baltistan. The request was allowed accordingly.

22. In case any of the police Officers and/or officials of Police who has/have completed or being completed mandatory trainings/courses or completed the requisite codal formalities before or after their Out of Turn Promotions, the competent authority may consider their individual promotion cases in accordance with law and applicable Service/Police Rules.

Before parting with this judgment, we appreciate and acknowledge the services rendered by Mr. Jawad Akram learned Home Secretary Gilgit-Baltistan and Mr. Gohar Nafees, the learned Deputy Inspector General of Police for their proper assistance to this Court.

These were the reasons for our short order dated 05.04.2018.
