NOTIFICATION

WHEREAS, Mr. Usman Bashir Janjua, the Secretary to Chief Judge (under suspension), was proceeded against, on account of Inquiry No.SAC.RE.01/2023, under the Supreme Appellate Court, Gilgit-Baltistan, Establishment Service Rules, 2022 on the charge of misconduct for submitting a reply/written defence which contained sarcastic and derogatory remarks against the Authority and his criticism and annoyance over the explanation sought from him; a Final Show Cause Notice under Rule 9(1) read with Rule 8(1)(b)(iii) of the Rules, 2022 (ibid) as to why he should not be removed from service was issued to him vide letter No.SAC.RE-01/2023/06 dated 24.10.2023.

AND WHEREAS, he was also proceeded against, on account of Inquiry No.SAC.REG-INQ-04/2023, under the Rules, 2022 (*ibid*), on the charges of corrupt practices and misconduct; the Inquiry Officer found that the said charges stood proved against him and proposed imposition of major penalty of removal from service upon him.

AND WHEREAS, he was also proceeded against, on account of Inquiry NO.SAC.REG-INQ-01/2024 under the Rules, 2022 (*ibid*), on the charge of misconduct; the Inquiry Officer found that the said charge stood proved against him and proposed imposition of major penalty of removal from service upon him.

AND WHEREAS, in all the three aforesaid disciplinary proceedings, the Hon'ble Disciplinary Authority afforded him distinctly an opportunity of offering his explanations qua the proposal of imposition of major penalty of removal from service upon him; thereafter, the Hon'ble Disciplinary Authority also afforded him an opportunity of being heard in person by him.

NOW,THEREFORE, the Hon'ble Chief Judge as Disciplinary Authority, after considering his explanations and hearing him in person and having found him being guilty of the aforesaid charges in all the three disciplinary proceedings, hereby orders that major penalty of removal from service be imposed upon Mr. Usman Bashir Janjua, the Secretary to Chief Judge (under suspension) forthwith.
